CHAMPVA allows caregivers to access VA health care services and private doctors who contract through CHAMPVA. It is an insurance program, so copayments might apply.

CHAMPVA is a second payer to other health insurance programs, including Medicare, which means your existing insurance has to pay first. Then, CHAMPVA may pick up remaining costs.

CHAMPVA Eligibility. To be eligible for CHAMPVA, you cannot be eligible for TRICARE, and you must be in one of these categories: The spouse or child of a Veteran who has been rated permanently and totally disabled for a service-connected disability by a VA regional office.
